This framework mandates the following conditions: at least one day of flexible working a week between 6am and 10pm with 2 hours compulsory availability, the ability for workers to freely structure the day in an agile way by working some of the time from the office and in part remotely (or entirely remotely in Smart Working), as well as the ability to introduce interruptions and re-starts throughout the working day.

Fincons Group's solution is based on Ethereum DLT technology (Distributed Ledger Technology) combined with sophisticated and innovative encryption techniques that guarantee the integrity, reliability and traceability of information managed as provided by DLT, as well as full GDPR compliance.

Initially, the pilot phase, starting in March 2019, involves 5 General Accounting Department employees, while the second phase, starting in July, will involve another 10 employees from other departments. The pilot will reach completion in September 2019.

The partnership between Fincons and the Municipality of Bari further confirms Fincons' strong connection with the Apulia region where the company has a feather in its cap: the Fincons Group Delivery Center. Based in the Bari main site, this Centre of Excellence houses over 500 employees and continues to grow. It supports the Group's clients in Italy and abroad by offering solutions and innovative highly-level end-to-end projects bringing value directly to the local area. The Smart Working project sits well within the CITADEL objectives whose aim is to improve strategies and processes within public administration to offer increasingly efficient digital services that are more inclusive and citizen-centred. Fincons and the Apulia Region are two of 12 partners from 5 European nations that cooperate in this project and that together create an ideal mix of different ideas and perspectives, by bringing their own specific capabilities and backgrounds: from social research and technology to the development of industrial prototypes that are applicable in real-life.

With this initiative, the Municipality of Bari perfectly combines smart contracts and smart working and positions itself yet again as a pioneer in innovative solutions to increase value and worker well-being. The authority is proving how the introduction of work-life balance policies that reconcile personal and professional life enables the implementation of DLT-based solutions that comply with art. 8 ter D.L. 135/2018, the so-called 'Simplification Decree'. The latter is the first national law to begin to outline a legal framework for the use of Blockchain technology-based solutions.
